WHEREAS, on August 11, 2026, Vickie Grimm, Williams County Auditor along with Stevie Lanzer and Karri Kolb, Williams County Deputy Auditors, met with the Board of Williams County Commissioners to discuss a possible increase of fees according to Ohio Revised Code Sections: 955.01, 955.05, 955.06, 955.07, 955.08, 955.09 and 955.14. Currently, Williams County is at \$18.00 for Dog Tags;

WHEREAS, per ORC 955.14, such resolution shall be adopted not earlier than the first day of February and not after than the thirty-first day of August;

WHEREAS, per ORC 955.14 (E)(1) & (E)(2) the Auditor also discussed the concern regarding the convenience fee associated with the collection of dog tags at various vendors throughout Williams County current fee is set at \$0.75 per tag. The Williams County Auditor made the recommendation for an increase from \$0.75 to \$2.00 to help offset the paperwork associated with the selling of the dog tags;

BE IT RESOLVED, by the Board of Williams County Commissioners that we do hereby approve a \$2.00 increase of the fee for Dog Tags per ORC 955.14. The increase is from \$18.00 to \$20.00 effective December 1, 2026. This increase would directly increase the 3 Year Dog License fee from \$54.00 to \$60.00 and the Permanent Tag from \$180 to \$200; effective December 1, 2026; also
